Dr. Pastor was Fellow and Founding Director of the Carter Center's Latin American and Caribbean Program (1985-98) and was National Security Advisor for Latin American Affairs (1977-81). He received a Ph.D. from Harvard University and is author of 14 books, including Toward a North American Community: Lessons from the Old World for the New. Dr. Pastor chairs the North American Forum on Integration.
